COUNTY OF VERMILION RIVER LAND USE BYLAW

BEING A BYLAW OF THE COUNTY OF VERMILION RIVER IN THE PROVINCE OF

ALBERTA FOR THE PURPOSE OF AMENDING THE COUNTY OF VERMILION RIVER MUNICIPAL DEVELOPMENT PLAN, BYLAW 19-03

| WHEREAS | Pursuant to the <i>Municipal Government Act</i> , R.S.A. 2000, Chapter M-26, as amended, authorizes a Council to amend a Municipal Development Plan; |

| AND WHEREAS | the Council of the County of Vermilion River deems it desirable to amend the Municipal Development Plan, Bylaw 19-03; |
| NOW THEREFORE | The Council of the County of Vermilion River in the Province of Alberta, duly assembled, enacts as follows: |

- 1. That Bylaw 19-03, being the Municipal Development Plan of the County of Vermilion River, is hereby amended as follows:
 - a. Section 5.2 Adequate Subdivision of Land
 - i. That the following be deleted and replaced as shown below:

Subsection 5.2.8, "Generally, a total maximum of 10.1 ha (25 ac) will be allowed for separation per quarter section. (See Figure 3)"

Subsection 5.2.8, "The combined total maximum area of land that may be subdivided from a quarter section for vacant rural residential parcels, abandoned farmstead separations, and developed rural residential parcels shall be 10.1 ha (25.0 ac). (See Figure 3)

 That Bylaw 19-03, being the Municipal Development Plan of the County of Vermilion River be amended by consolidating this amendment into a single, updated document.
